By Signing below, I hereby agree to the following:

- 1. I understand that while participating in Inspirational Dance classes, my child(ren) and or myself maybe at risk for physical illness or injury. I give my full consent for my child(ren)/ myself to actively participate in class, rehearsals, online classes and performances from this date forward. I attest that my child(ren)/myself are in good condition and will supply any additional information regarding any physical restrictions or special needs, if any. In the event of illness or injury, I authorize Inspirational Dance to obtain necessary treatment on my child(ren)'s behalf at any necessary emergency facility. I also assume the responsibility for the payment of any such treatment.
- 2. I agree to hold harmless Inspirational Dance and any of its owners, officers, operators, staff, employees, volunteers, and or agents of any wrong-doing or negligence.
- 3. I give full permission for inspirational Dance to use pictures or video from picture day, classes and or performances for advertising purposes. I understand that his/her name will never be used.
- 4. I understand there are NO REFUNDS (including paid in full tuition). Inspirational Dance will/may offer credit only in certain circumstances. NO EXCHANGES on merchandise purchased (Tights, Dancewear costumes etc.)
- 5. Early Registration \$25 New Student \$20 returning student- New Registration \$30
- 6. I understand **TUITION** is due 1st week (1st-7th) of every month thereafter \$25 late fee applied to any delinquent payments (NO EXCEPTIONS) Once taken first class, I am responsible for FULL TUITION for DANCE YEAR and costume deposits and balances.
- 7. I understand there is a **mandatory dress code**, because what looks awesome on the stage begins in the studio/dance training. I understand my child is to come with uniform on and ready to participate in class or online classes.
- 8. I understand I am responsible to pay any and all fees, including registration, full tuition and costume(s) to Inspirational Dance for the dance year from starting September-June and or Summer intensive program. I understand there is a recital and tickets go on sale at the end of the dance season. I am responsible to purchase tickets if I want to see my child/dancer perform.
- 9. I understand that if owe Tuition 60 days, I will/can be dropped from all my classes. NO EXCEPTIONS and will be responsible to pay balance owed.
- 10. I understand that excessive absences will result in being dropped, pay for privates if choreographer(s) are available and may not participate in recital/ performances, no matter what time of year.
- 11. I understand I may need to do alterations for costumes in order to fit my child(ren). I understand that tights, accessories, shoes aren't included in costume fees.
- 12. I understand in case of inclement weather an email, text, social media will be posted.
- 13. I understand if my child is sick, I will notify studio by email and phone. Makeup classes will be equal or equivalent to level and style of dance under director/ teacher's approval.

Inspirational Dance will not tolerate any outburst from parents towards the director or staff members and reserves the right to immediately cancel their current contract. - 15. I understand there's no video or flash photography. I understand to drop off and pick up child on time. There will be a \$25 fee and up for late pick up.
- 16. I understand there's a performance /rehearsal fee \$30 added at the last month tuition.
